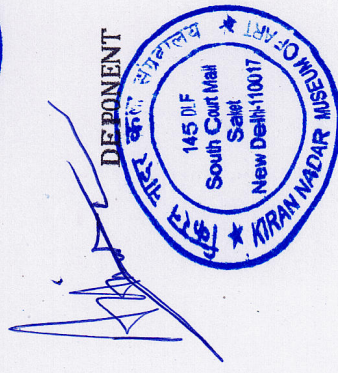
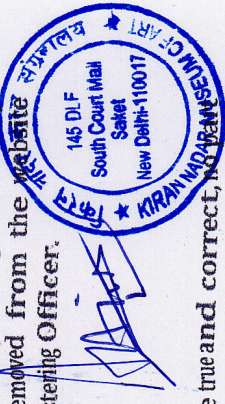
AFFIDAVIT

I, the above named deponent, do hereby solemnly affirm and state that I am **Principal Employer** of M/s. **KIRAN NADAR MUSEUM OF ART, 145- DLF South Court Mall Saket, New Delhi - 110017** and competent to swear this affidavit:-

1. That I am being the Manager (Designation) of the above establishment M/s. **KIRAN NADAR MUSEUM OF ART, 145- DLF South Court Mall Saket, New Delhi - 110017** and well conversant with the functioning of the Company/ establishment and state on oath/ depose this affidavit.
2. That the deponent is **Principal Employer** (as the case may be) of the establishment M/s. **KIRAN NADAR MUSEUM OF ART, 145- DLF South Court Mall Saket, New Delhi - 110017** (hereinafter referred to as the Principal Employer) is an independent legal entity and Principal Employer in accordance with the provisions of the Contract Labour (Regulation & Abolition) Act, 1970 and rules made there under.
3. That the establishment of deponent has entered in to an agreement with **M/S G4s Secure Solutions (INDIA) PVT.LTD., M/S Updator Services PVT. LTD., M/S Soutions Unlimited.** (Contractors) to carry out the work as per annexure on **Security, Maintenance, Housekeeping** for providing the 27 number of workers, which shall remain in force from as per annexure.
4. That the deponent does not have/have worker(s) of the contractor (s) establishment deployed/ shall be deployed at the premises of the deponent establishment and/or.
5. That those workers deployed/shall the deployed by the deponent and performing the same & similar kind of works as being done by the workers directly employed by the Principal Employer are being/ shall be paid the same wages as applicable to the directly employed worker(s) of Principal Employer.
6. That the deponent undertake that each and every worker deployed by the deponent is/are being/shall be paid not less than the minimum rates of wages fixed for their category of employment from time to time by the Govt. of Delhi under the provisions of minimum wages Act, 1948 including overtime weekly off etc. and it shall be paid through the account payee cheque/ECS bank transfer (other than workers engaged in construction work/ daily paid) The payment of wages will be made in the presence of authorized representative of the deponent (Principal employer), and duly verify by him/het.
7. That the deponent shall ensure that all contractor(s) provide(s) all statutory benefits under the applicable Labour Laws in respect of all worker(s) deployed/shall be deployed in the premises of the deponent (principal employer), failing which the same shall be provided by the deponent as per the provisions of the Contract Labour (R&A) Act, 1970 and rules made there under.
8. That the process(es)/job(s)/work on which the contract workers are to be deployed/engaged is/are not abolished by any Authority on Board under the provisions of Contract Labour (R&A) Act, 1970. That the deponent has uploaded the required information and documents as per check list in their website "www.knma.in" and the website is not be password protected and will be updated every month, further the required information and documents shall not be removed from the website without prior permission and changes, if any shall be intimated to the Registering Officer.
